It does. It does not require that pre-construction notifications include surveys for eelgrass, microalgae, or forage fishes

Here is some justification text from the NWP.

"Compliance with general conditions 3 and 5 will ensure that the authorized activity has minimal adverse effects on spawning areas and shellfish beds, respectively."

"The authorized activity cannot have more than minimal adverse effects on breeding areas for migratory birds, due to the requirements of general condition 4."

Here is the text of the General Conditions:

3.Spawning Areas. Activities in spawning areas during spawning seasons must be avoided to

the maximum extent practicable.
Activities that result in the physical destruction (e.g., through excavation, fill, or downstream smothering by substantial turbidity)
of an important spawning area are not authorized.

4. Migratory Bird Breeding Areas. Activities in waters of the United States that serve as breeding areas for migratory birds must be avoided to the maximum extent practicable.

Jennifer- I think your response is appropriate. It demonstrates a willingness to work with them, but also lets them know we need additional information before we can make any decision. It's good that you point out that you'll be participating in the SEPA process. In case you don't have it, I'm attaching the SEPA checklist. It will be interesting to see how they respond to question 8a "What is the current use of the site and adjacent properties? Will the proposal affect current land uses on nearby or adjacent properties? If so, describe."

Do you know if the area impacted is considered a "new project area" by the Corps? If so, the Corps shouldn't permit the action until there is a lease or permit from the State. The nationwide permit cannot be used for projects that directly impact more than 1/2-acre of submerged aquatic vegetation beds – which the July 1 survey should answer.

Would you mind taking a look at this response and let me know if you see any red flags? I want to make sure that I am getting the correct information to the Tribe at each step in the process. After a quick look at their proposal, I have noticed that they still have not provided all of the information that we would need to complete the CD process (e.g., annual timing of seeding and harvest, complete descriptions of harvest techniques, information on the total acreage of netting at any given time). Sue and I are going to take a closer look at the proposal on Monday.

Ralph,

It is really hard (if not impossible) for me to tell you what would or would not work at the Refuge without going through an analysis of the proposal. Since a permit from ACE and the County are necessary for DNR to issue the lease, it makes sense for us to begin our Compatibility Determination process after those permits have been granted (so we know the project description will not change). We may also be able to use some of their SEPA and NEPA documentation to inform our process and reduce some of the overlap of efforts.

We will be looking at the proposal to see if it will negatively impact the purpose of the Refuge. We do that through a Compatibility Determination that is backed up by NEPA documentation. We will then let DNR know if there are any negative impacts so they can use that information in developing the lease. We will also provide information for the ACE and County permitting processes as needed.
