I would like it noted that I am strongly opposed to application of any aquaculture activity or any other commercial enterprise by tribal or non-tribal organization within the Dungeness Wild Life Refuge. My objection is based on the premise that the Dungeness Wild Life Refuge is just that, a refuge for wild life (both marine and land based). If a commercial operation can not be sustained or economically justified without the usurping of federal land or designated refuge protectorate then the enterprise should not operate or should look to sites that do not impact on a refuge.
